

PROGRAM ACCEPTANCE POLICY

Mobile Crane Operator – 25 Weeks	\$17,882.00	\$760.00	If you do not have a Class 03 or 01, you will be required to pay \$130.00 to the Department of Motor Registration in order to get a permit for a commercial license

PROCEDURE

You are required to complete and submit items 1 – 5 below to be eligible for acceptance; **incomplete applications/documentation will NOT be processed. You are only eligible for acceptance once ALL documents (1-5) are submitted to the College.** Once you have met the eligibility requirements for acceptance and a seat is available, an acceptance letter will be mailed to you. Once accepted, an \$80 non-refundable confirmation fee is to be paid within two weeks of receipt of your Letter of Acceptance. The fee is required to hold your seat in the program. If not paid, you will lose your seat for that program. Upon acceptance, you can turn down entrance into that program on 2 separate occasions and move ahead to a future program. Once you have turned down acceptance into a program twice, **you will have to reapply** to that program (*your application will not be kept on file*). Required documents below:

1. **Complete the Application Form** (on reverse)
2. Enclose a copy of your **Official High School Transcript**, ABE or GED showing you have graduated. If you are currently completing high school, submit your current grade 11 or 12 marks. To apply as a mature student (19 years or older without successfully completing high school), you must complete a CAAT Assessment (Level B) for Grade 10 or higher equivalency. Please call the College to arrange a time.
3. Submit a **\$45.00 Application Processing Fee**. Payable by cash, cheque or money order/bank draft. Debit or credit is accepted (*Non-refundable*).
4. **Submit a copy of your valid Class 05 Newfoundland Driver's License**
The Class 05 must be valid for a minimum of one year. If you have an out of province license, it must be transferred to a Newfoundland license, before you are eligible for acceptance.
5. **Complete the Medical and Consent Form and return the ORIGINAL copy to the College.** Medical is to be completed by a physician.

NOTE: If you are an applicant with a documented Learning Disability, please submit documentation along with your application.

FUNDING

- For participants seeking funding through Immigration, Population Growth and Skills, we recommend you contact your local office as soon as possible as funding application submission dates are put in place. IPGS offices have procedures in place for assessing clients for approval for training & funding.

You will have the essential skills, knowledge, and attributes to operate as an apprentice in the construction industry. A Class 03 license with Endorsements 8 and 9A are included on the program.
